

## Wangaratta Undercover Arena

### CLINIC - Warning and Waiver of Liability

By signing this agreement You the Instructor and are waiving your rights to sue Wangaratta Equine Services for any responsibility or liability for accidents, damage, loss, injury, permanent disability or death to yourself or horse - as a result of hiring the Undercover Arena, 218 Tone Rd Wangaratta.

This agreement includes Yourself, Participants under your instruction, all horse(s) intended on being ridden during the Clinic, Spectators and other Persons assisting or attending the facility at the time of hire.

Wangaratta Equine Services accepts no liability for accidents related to horse transport, movement and horse riding. Your participants transport, handle, saddle, participate with and ride horse(s) at their own risk.

I understands and acknowledges that horse riding is a dangerous activity and that horses can act in a sudden and unpredictable way, especially if frightened or hurt, which notwithstanding the best endeavours, skill, care and diligence of the rider, handle and instructor creates an unavoidable risk or physical harm.

I have read and understood the general rules and conditions of use handout. I ensure that all participants will be provided with a copy of the general rules and conditions of use prior to using the facility, and the participants will abide by these rules. I understand failure to comply with these rules may result in refusal for future hiring of the arena.

I declare that I am a qualified and licensed instructor and capable of providing Instruction for the purposes of this clinic. I have a current public liability cover of minimum \$10,000,000 and can provide proof of these documents.

I accept that it is my responsibility to ensure that all riders at my clinic are covered by PERSONAL ACCIDENT insurance, either by my own insurance, or by insurance they have taken out themself, or by a membership they have with a club, such as PCAV that provides 24/7 personal accident insurance.
