By signing this agreement You are acting on behalf of the hire club/organisation and are waiving your rights to sue Wangaratta Equine Services for any responsibility or liability for accidents, damage, loss, injury, permanent disability or death to yourself or horse - as a result of hiring the Undercover Arena, 218 Tone Rd Wangaratta.

This agreement includes Participants and Members of the Club/Organisation hiring the arena, Your horse(s) intended on being ridden during the Activity, Spectators and other Persons assisting or attending the facility with your Club/Organisation.

Wangaratta Equine Services accepts no liability for accidents related to horse transport, movement and horse riding. You transport, handle, saddle, participate with and ride Your horse(s) at Your own risk.

The club/organisation understand and acknowledge that horse riding is a dangerous activity and that horses can act in a sudden and unpredictable way, especially if frightened or hurt, which notwithstanding the best endeavours, skill, care and diligence of the rider, handler and guide or instructor creates an unavoidable risk or physical harm.

I have read and understood the above general rules and conditions of use. I ensure that the club members will be provided with a copy of the general rules and conditions of use prior to using the facility, and the participants will abide by these rules. I understand failure to comply with these rules may result in refusal for future hiring of the arena.

Any accidents, hazards, risks or damage to the arena must be reported immediately to Wangaratta Equine Services staff.

I have been given an induction and tour of the facilities. I am aware of parking, yards, toilets, hosing/water, arena entry/exit, and the equipment for cleaning up and disposing manure/feed waste.

I declare that I am a committee member of the hiring club/organisation, and there is a current membership that provides members with personal accident insurance and public liability cover of minimum \$10,000,000 and can provide proof of these documents.
